Expected Impact—what is it?

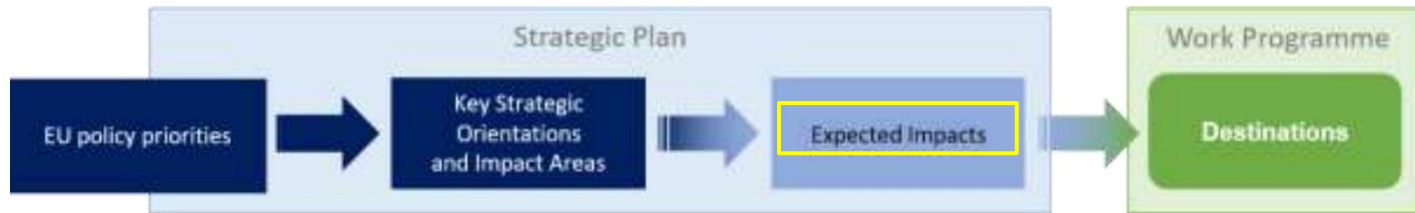
*“Horizon Europe marks **a paradigm change in the design of the EU research and innovation programmes** by moving from an activity-driven to an **impact-driven approach**, which allows it to make **targeted interventions, based on mutually agreed priorities**. This is, for instance, **reflected in the so-called destinations and topics of this work programme**, which **put forward the impacts we want to achieve and the outcomes we expect, but leave the manner of achieving them to the imagination and skills of the applicant.**”*

Expected Impact—what is it?

From EU priorities to work programme destinations



- Expected impacts are the **long(er)-term, wider effects project results** will have on **society, science and the economy**.
- Expected impacts are **the targets of research and innovation** funded under the Horizon Europe Programme

Destination 1 “Democracy and Governance” – Objectives & “expected impact”

Knowledge, data, and science-based recommendations for strengthening of:

- Freedom, rule-of-law and trust in democratic institutions
- Accountability, transparency, effectiveness, and trustworthiness of rule-of-law institutions and policies
- Political participation, social dialogue and social inclusion, civic engagement and gender equality
- Protecting democracies from threats

Destination 2 “Cultural Heritage” – **Objectives** & “expected impact”

- Promote **access** to and engagement with cultural heritage and improve its **protection, valorisation (i.e. “value; appreciation of”), and restoration**
- Research and innovation on the cultural and creative industries (as drivers of innovation and employment) will support the sustainable growth and creation of job
- Establishment of a European digital space for cooperation in the field of cultural heritage => “Museums Cloud”/“ECCCH”
 - Sub-divided into three segments: **green** - **digital** – **innovative**

Destination 2 “Cultural Heritage” – Objectives & “expected impact”

- Better access to cultural heritage
- Improved understanding of cultural heritage
- **Shared values and traditions become more present, emergence of a feeling of belonging, and formation of a European identity**
- Improved governances and cooperation of European cultural heritage institutions
- Better **protection**, valorisation, conservation and restoration, EU global leadership in conservation management, **digitalisation**, and the curation of cultural objects
- Sustainable and inclusive cultural tourism in Europe
- **Strengthening (of) the innovation potential of the cultural and creative industries** via contributions to sustainable growth and employment

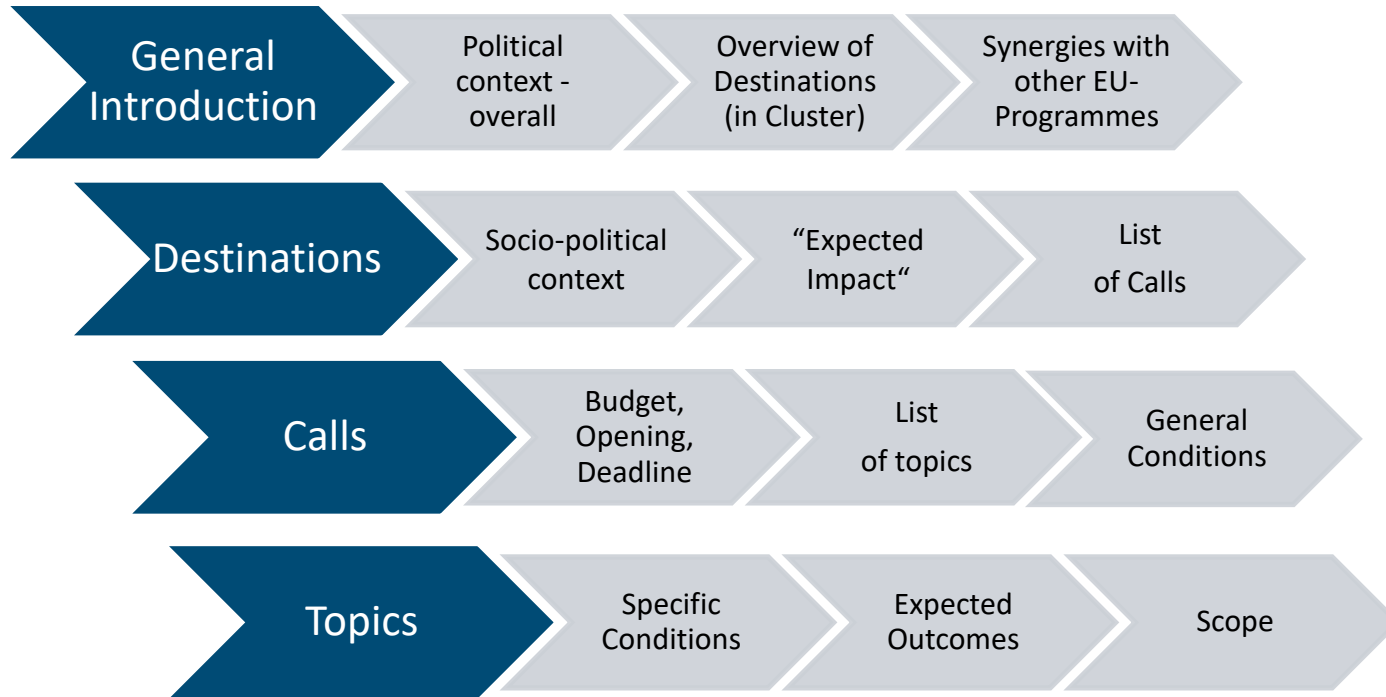

<i>Indicative budget</i>	The total indicative budget for the topic is EUR 3.00 million.
<i>Type of Action</i>	Coordination and Support Actions

<i>Eligibility conditions</i>	The conditions are described in General Annex B. The following exceptions apply: The Joint Research Centre (JRC) may participate as member of the consortium selected for funding.
<i>Procedure</i>	The procedure is described in General Annex F. The following exceptions apply: The granting authority can fund a maximum of one project.
<i>Legal and financial set-up of the Grant Agreements</i>	The rules are described in General Annex G. Topic Structure – Expected Outcomes & Scope

Expected outcomes – What should be achieved by the project?

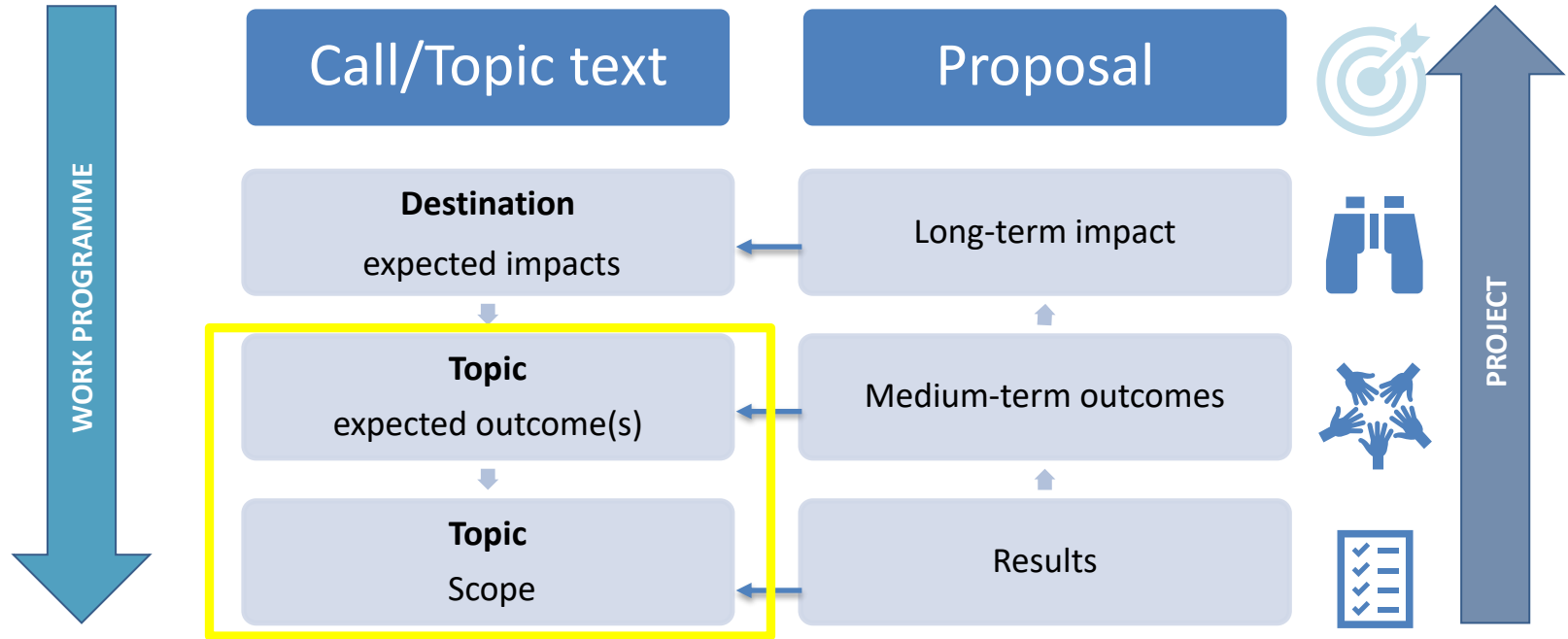
Desired (short-term & medium-term) achievements of the project that contribute to the Horizon Europe Strategic Plan, e.g. via the use of project results by relevant target groups.

=> **Clearly state** in your proposal, how you **intend** for your project will contribute to these “expected outcomes”.

Scope – What should the project deal with?

Usually a description of the **context/problem** and then a brief description of the research area/desiderata (e.g. specific requirements of the Commission) to be addressed by the project. If applicable, references to target groups to be included, geographical breadth or similar.

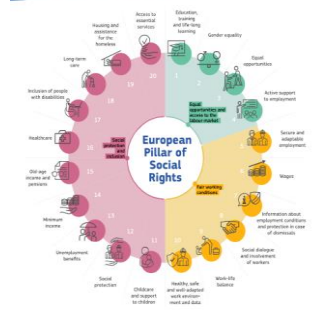

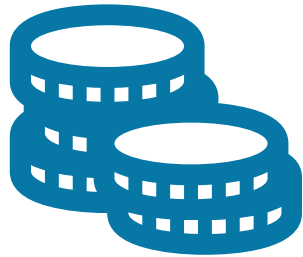

DEMOCRACY-2024-01-05 Gender-roles in extremist movements and their impact on democracy

(RIA, 9m€, 3 projects)

Expected Outcome (contribute to **all** listed):

- Develop a critical understanding of the construction and performance of gender roles in extremist, identitarian (i.e. [alt-right](#)) and nationalist movements and their impact on democracy, EU values and fundamental rights
- Provide evidence-based insights into the role of online communities in the promotion of reactionary, identitarian and extremist ideals, focusing in particular on different forms of masculinity from an intersectional perspective and drawing on engagement with these communities
- Examine gender roles in political leadership styles and narratives, especially in nationalist and extremist parties, and their impact on democratic participation, decision-making and trust in governance, and propose alternative models for more democratic leadership
- Develop innovative methods, policy approaches and tools to tackle antidemocratic narratives and tendencies, characterised by identitarian, nationalist and extremist ideals

DEMOCRACY-2024-01-05 Gender-roles in extremist movements and their impact on democracy (RIA)

Scope: Including, but not limited to: investigation/analysis of...

- Misogynist, anti-LGBTIQ+ & racial/ethnic minorities racist groups/milieus, **the role of such online discourse in online platforms** in the **constitution** of extremist movements
- **Different types of masculinity and how (these masculinities) relate to gender-based and political violence, hate crimes, perceptions around EU values and political change**
- **Interrelationship between top-down hyper-masculinistic* leadership styles and bottom-up identitarian, nationalist and other extremist movements and **their impact on democratic participation, decision-making and trust in (democratic) governance****
- **Development of innovative methods, policy approaches, and tools for policymakers and practitioners to address underlying roots of violent, discriminatory and illiberal discourse and actions in public and online spaces (policy/practical tools to reach and engage men in these communities)**
- **Interdisciplinary research approach (social sciences and political sciences, informatics/AI expertise)**

- Be **interdisciplinary** (academic disciplines represented, research methods and approach utilised, thematically-relevant stakeholder groups represented)

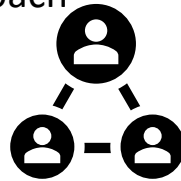
Can include following types of participants:

ACADEMIC:

- **political scientists** (e.g. policy studies & analysis, incl. public policy scholars; political behaviour analysis; **sociologists** (e.g. of race); anthropologists (e.g. studying hate groups, online communities); **historians** (of right-wing movements, e.g. fascist movements); **philosophers** (looking at ideology as a subject); psychologists; **computer science scholars** (information scientists; computer engineers)

NON-ACADEMIC:

- **AI developers/companies** (e.g. as potential advisory board members); **regional/national policymakers**; **NGOs** (focused on women or ethnic/racial minorities)

Expected Outcome (contribute to **all** listed):

GREEN

- Innovative solutions, validated in pilot trials, demonstrating how strategic investments in the spirit of the New European Bauhaus initiative in cultural heritage (which may include cultural landscapes) and the CCIs can be successfully realised
- Increase the understanding and visibility of the role that cultural-led innovation integrating the New European Bauhaus approach can play
- Wider involvement and social inclusion of citizens in the preservation and enhancement of cultural heritage through engagement with local ecosystems



HERITAGE-2024-01-01 New European Bauhaus – Innovative solutions for greener and fairer ways of life through arts and culture, architecture and design for all (IA)

Scope: proposals should...

GREEN

- **Test, demonstrate and refine innovative solutions; **bring together** infrastructures, research, practice, management, companies from diverse cultural & creative sectors and bring communities on the ground with them**
- **Conduct at least 5 small-scale trials under real-world conditions in a minimum of 3 EU Member States/Associated Countries**
- Solutions should be **replicable** and **consider**:
 - **Use of renewable materials; role of arts, design and quality architecture; synergies between craft and industrial techniques/skills**
 - **Regeneration, life extension** (i.e. smart monitoring, conservation and restoration), **re-use/transformation** of cultural heritage buildings and landscapes



HERITAGE-2024-01-01 New European Bauhaus – Innovative solutions for greener and fairer ways of life through arts and culture, architecture and design for all (IA)

Scope (continued): proposals should...

GREEN

- Serve as guidance for actors in other territories/contexts
- Build on existing knowledge, activities, networks and platforms (especially those already funded under New European Bauhaus initiative)
- Contribute to New European Bauhaus Community, NEBLab and other relevant NEB actions via (i.e. sharing of information/best practice sharing/results)
- Evaluation of proposals will focus on geographic location of planned demonstration activities
- European Union and Associated Countries in NUTS level 1 should be involved (Associated Countries with no NUTS level-1 categorisation=a single geographical region)

NUTS: Nomenclature of territorial units for statistics (a hierarchical system for dividing up the economic territory of the EU and the UK)

Steer the transformation of our societies along three inseparable values:

- **sustainability**, from climate goals to circularity, zero pollution, and biodiversity
- **aesthetics**, quality of experience and style beyond functionality

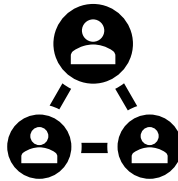
Can include following types of participants:

NON-ACADEMIC:

- **Business managers/entrepreneurs** (e.g. design, fashion, crafts fields; arts & heritage professionals); **regional/national policymakers; CSOs** (e.g. community housing collectives at municipal level)

TRANSFORMATIONS-2024-01-01 Policy recommendations from socio-economic impacts of loneliness in Europe (CSA 3m€; 1 project [expected])

Expected Outcome (contribute to **all** listed):

- Contribution to behavioural changes for a more resilient and just society
- Information on key aspects of the impacts of loneliness in Europe by pooling of socio-economic data to existing data
- Evidence-based recommendations for social and economic policies to prevent, counter, and manage loneliness in Europe at individual and population levels
- Creation of a framework to monitor loneliness in the long-term
- Formation of a representative network of experts, stakeholders and policymakers involved in research and policy actions addressing the socio-economic impacts of loneliness

TRANSFORMATIONS-2024-01-01 Policy recommendations from socio-economic impacts of loneliness in Europe (CSA)

Scope:

- **Cooperation with EU projects/initiatives on loneliness** (e.g. JRC/DG EMPL „Pilot Project on Loneliness“); **use of existing data** to pool economic data on individual & societal (forms of) loneliness
- **Comparative analysis** of aspects of **commonly agreed upon (i.e. “defined”)** socioeconomic and geographic **risk factors/drivers and trends of loneliness/specific populations, within/between EU Member States**
- **Provide evidence-based policy recommendations** to help design:
 - **effective loneliness policies and**
 - **develop tools for long-term monitoring of loneliness** at individual and societal levels
- **Nurture public debate on loneliness**, especially the stigma associated with loneliness
- **Promote** the use of **new technologies to quantify and assess the social and economic effects of loneliness (in Europe)**
