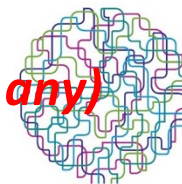
- **Objectives:**

- **Expected results:**

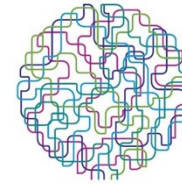

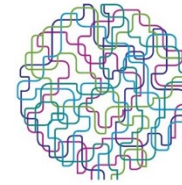
