





Is my company innovative enough? How can I make sure my project is suitable?







When can I receive the grant money? What costs are eligible?

Main Eligible Costs

Personnel, travel, equipment, products, services, indirect costs (25% of above), and subcontracting

Main Ineligible Costs

Currency exchange losses, debt charges, interest, deductible VAT, excessive expenditure,....

costs have to be actually incurred by the beneficiary for actions during project duration, and recorded in the accounts.




