





Evolution in participation between FP7 and Horizon 2020:







InvestEU for Research and Innovation



Stimulates more investment in research and innovation, notably by the private sector; leverages and complements national/regional initiatives

No market distortion: intervention only to address financing gaps in the R&I delivery chain (notably due to high risk)

Support through:

- InvestEU Fund
- InvestEU Assistance
- InvestEU Portal

Leverages an estimated € 200 bn of investments into R&I; market-based finance for the exploitation and scale-up of European R&I

R&I Missions

Relating EU's research and innovation better to society and citizens' needs; with strong visibility and impact

A mission is a portfolio of actions across disciplines intended to achieve a bold and inspirational and measurable goal within a set timeframe, with impact for society and policy making as well as relevance for a significant part of the European population and wide range of European citizens.

Horizon Europe defines mission characteristics and elements of governance, and 5 missions areas.

Specific missions will be programmed within the Global Challenges and European Industrial Competitiveness pillar (drawing on inputs from other pillars)

Definitions in the FP Regulation

(5) 'mission' means a portfolio of excellence-based and impact-driven R&I actions across disciplines and sectors, intended to:

- achieve, within a set timeframe, a measurable goal that could not be achieved through individual actions
- have impact on society and policy-making through science and technology
- be relevant for a significant part of the European population and a wide range of European citizens;

New generation of objective-driven and more ambitious partnerships in support of agreed EU policy objectives

Key features:

- Simple architecture and toolbox Common set of criteria
- Coherent life-cycle approach
- Strategic orientation

Based on longterm dimension and need for high integration; partnerships based on Articles 185 / 187 of TFEU and the EIT-Regulation supported by Horizon Europe









European Partnerships



European Partnerships: what is new?

- Only support partnerships if there is evidence that they are more effectively achieving policy objectives than Horizon Europe alone
- Fewer partnerships with higher impacts
- Common and coherent framework of criteria along the life cycle of partnerships, across all pillars, even across programmes and other regulations (e.g. EIT, DEP, space)
- Unified umbrella branding to improve visibility
- Increase openness and encourage a broader set of actors to participate
- Improve coherence between partnerships and Horizon Europe, also the missions
- Time limited with conditions for phasing-out the Programme funding

Preparation: step-by-step



Preparation: step-by-step

- At the core of the preparation: National research funders/governmental research organisations and national ministries • Core tasks:
 - further elaboration of the partnerships proposal (in close collaboration/co-creation with COM services)

<u>∧</u> necessary to agree on the objectives, expected impacts, compliance with partnership criteria etc.

- preparation of the **Strategic Research and Innovation Agenda**, and the process that will allow to identify the topics in work plans.
- On that basis: preparation of the Horizon Europe call text for a programme co-fund action implementing the European Partnership, subject to comitology and COM decision adopting the WP.
- Consortium of research funders prepares and submits the proposal for a cofund action (including the draft annual work plan year 1), subsequent, evaluation, Grant Agreement preparation
- Launch of the European Partnership, preparation and launch of activities, including e.g. calls for proposals
- Annual work plans subject to COM approval.









Governance



The consortium has to describe in their proposal the governance for the Partnership (on the basis of prior discussions and agreement with COM)

- Internal governance of the consortium (consortium management, including the preparation of the draft annual work plan)
- External governance with a steering/governing board, where for example Ministry representatives, COM and if appropriate others organisations have a seat (providing advise and guidance endorsing the annual draft work plan, subject to approval/request for modification by COM)
- Other elements, as appropriate, e.g. stakeholder forum, scientific advisory board, deployment board

Important: clearly identify the relevant national representatives that can ensure the initiative is well embedded in the national policies and priorities, and ensure national commitments and contributions.










Governance













Openness and transparency



- Calls of the Partnership:
 - Can in principle be open as Horizon Europe calls, if agreed by the partners;
 - In the past: funding mostly limited to legal entities from countries that contribute with funding to the call (based on national funding rules), eligibility for (un-funded) participation should always be possible.
- Ensure involvement and consultation of relevant stakeholders (beyond partners) and Member States in the development/ validation of Roadmaps/SRIA and the annual priority setting.


Portfolio of candidates for European Partnerships






Types of Action









Indirect actions: research and innovation activities to which the Union provides financial support, and which are undertaken by participants

Research and innovation





Action primarily consisting of activities aiming to establish **new knowledge** and/or to **explore the feasibility** of a new or improved technology, product, process, service or solution. This may include basic and applied research, technology development and integration, testing and validation on a small-scale prototype in a laboratory or simulated environment







Innovation





Action primarily consisting of activities directly aimed at producing plans and arrangements or designs for new, altered or improved products, processes or services, possibly including prototyping, testing, demonstrating, piloting, large-scale product validation and market replication.







Innovation and market deployment





Actions embedding an innovation action and other activities necessary to deploy an innovation in the market, including the scaling-up of companies, providing Horizon Europe blended finance (a mix of granttype funding and private finance)









ERC frontier research





Principal investigator-led research actions, hosted by single or multiple beneficiaries (ERC only)







Training and mobility





Action geared towards improvement of skills, knowledge and career prospects of researchers based on mobility between countries, and, if relevant, between sectors or disciplines.








Programme co-fund





Action to provide co-funding to a programme of activities established and/or implemented by entities managing and/or funding research and innovation programmes, other than Union funding bodies. Such a programme of activities may support actions directly implemented by those entities or by third parties to whom they may provide any relevant financial support such as grants, prizes, procurement, as well as Horizon Europe blended finance.










Public procurement





Pre-commercial procurement: Action with the primary aim of realizing pre-commercial procurement implemented by beneficiaries that are contracting authorities or contracting entities.

Public procurement of innovative solution:
Action with the primary aim of realising
joint or coordinated public procurement of
innovative solutions implemented by
beneficiaries that are contracting
authorities or contracting entities.









Coordination and support





Action contributing towards the objectives of the Programme, excluding research and innovation activities, such as standardisation, dissemination, awareness-raising and communication, networking, coordination or support services, policy dialogues and mutual learning exercises and studies







Prizes





Inducement prize: prize to spur investment in a given direction, by specifying a target prior to the performance of the work

Recognition prize: Prize to reward past achievements and outstanding work after it has been performed
