# LEGAL BASIS AND OPEN CALLS

#### **Regulation (EU) 2021/2085**:

 Adopted by the Council of the European Union on 19/11/2021 -Establishes the Joint Undertakings (JU) under Horizon Europe (HE).
Single Basic Act (SBA).

#### **JU Membership:**

- Commitment Letter & Membership Agreement  $\rightarrow$  All private Members
- Governing Board (GB)  $\rightarrow$  15 private Members + EU
- Technical Committee (TC) → All private Members + EU
  - Generation Founding Members: 27
  - □ Associated Members: 12 (status at March 2022)

#### Members main "Rights & Obligations":

- Governance rights (GB and TC);
- Contribution to SBA objectives and SRIA HLGs;
- Collective In-Kind Contributions commitment: total minimum requirement = EUR 2.4 billion (IKOP & IKAA)
- Admin costs (Financing Agreement) between PM and the JU to cover 50% of the total JU admin costs

### Calls for Associated Members (CEI)

 Call for Expression of Interest to select additional Associated Members based on key competences, ability to engage on longterm commitment and IKC (Article 7 of the SBA) – 1<sup>st</sup> CEI to be launched by CAJU expected 1<sup>st</sup> half of 2023




### Open calls framework and rules

- Calls and topics designed to meet the SBA objectives/impact, the SRIA HLGs and Horizon Europe Rules for Participation
- SBA derogations to the Horizon Europe rules for participation (where applicable)
- CAJU Rules for Submission, Evaluation, Selection and award criteria
- The admissibility, eligibility, award criteria and conditions are set out in the CAJU Work Programme (Chapter: Conditions and Management of the Calls) and under the General Annexes to Horizon Europe Work Programme 2021/2022
- Specific conditions x topic are set in the call/topic descriptions

# LEGAL DOCUMENTS OF THE CALL

**HE Model Grant Agreement** (Annex V – Specific rules for JU actions):

□ Actions shall contribute to the CAJU objectives and SRIA;

□ JU right to object to transfer of ownership or exclusive licensing of results outside the EU - up to 10 years from end of the action;

Beneficiaries' obligation on exploitation - up to 10 years from end of the action;

Description of in-kind contribution (IKC) at proposal level;

□Minimum level of IKC set at project level, special condition set in all topics of the 1<sup>st</sup> CAJU call (NB: IKC is a Members' obligation).



- 1. Applicants submit their questions via <u>CFP-2022-01@clean-aviation.eu;</u>
- 2. Questions are collected by CA JU and if/where relevant, addressed after analysis;
- 3. Q&As are published once available via the <u>Funding & Tender Opportunities Portal</u>. Two-Three Q&A releases are foreseen:
  - 2. The first is planned on or soon after **27 April 2022**\*
  - 3. The second is planned on or soon after **26 May 2022**\*
- 4. Applicants are advised to regularly check the JU website and <u>Participant Portal</u> for updates to the call information and questions
  - ✤ DO NOT ask for replies via the Functional Call Mailbox !
- 5. FAQs can be submitted to the above functional call mailbox **until 23 May 2022, 17:00 (Brussels Time)**.
  - N.B. Questions received after the deadline will not be taken into consideration !
